The Disc System

DISC - Database and Intranet for Safer Communities

The aim of the Bristol City Centre BIDs Business Crime Reduction Partnership is to ensure that the area remains as safe and crime-free as possible.

The BCRP is a collaboration between Bristol City Centre BID and Broadmead BID under the auspices of Destination Bristol.

We work very closely with The Galleries and Cabot Circus shopping centres as well as Avon & Somerset Constabulary; Bristol City Council; BID rangers & ambassadors; retailers; and security staff.

Disc is the secure information-sharing system from Littoralis.

Disc enables you to submit Incident and Intelligence Reports about low-level crime and anti-social behaviour in your area; view a database of Known and ID-Sought 'Subjects' and view summaries of reports that have been submitted about them by other Members.

You can also find out about upcoming Events, receive 'Alerts' and other current awareness information, read important News about your scheme or organisation, and access an online library of useful documents, uploaded by your Administrator. You will also receive a weekly eNewsletter with all the latest updates from your Disc system (if this has been enabled by your Administrator).

COVID-19 ADDITIONAL RELIEF FUND

COVID-19 Additional Relief Fund (CARF) is a new relief for businesses affected by the pandemic but ineligible for existing support linked to business rates.

The relief is available to reduce business rate bills in respect of 2021/22 only.

Businesses can get up to 100 per cent of their business rates for the 2021/22 financial year credited back. Depending on the level of demand on the fund, the amount of relief may be capped so we can support as many businesses as possible.

To be eligible, a business must be able to demonstrate they have been adversely affected by the pandemic and that they are unable to adequately adapt to that impact.

Applications to the fund must be made by 31 May 2022. We will then assess all applications and notify businesses as soon as possible of the outcome.
